INTERNATIONAL TRAVEL REQUIREMENTS

U.S. CITIZENS: Valid U.S. Passport. SMALLPOX VACCINATION ONLY IF RETURNING TO USA FROM INFECTED AREA.

Non-U.S. CITIZENS: Valid passport of own nationality. Smallpox - same as above. Alien registration card. Sailing permit issued by the Dept. of Internal Revenue. If visiting countries in Eastern Europe, re-entry permit issued by the Immigration and Naturalization service.

THE FOLLOWING ARTICLES MAY BE BROUGHT INTO SCANDINAVIA DUTY FREE: Medicines for private use; reasonable quantities of film; 400 cigarettes or 100 cigars or 1 pound of tobacco; two quart bottles of liquor or wine.

U.S. CUSTOM REGULATIONS: On return to the United States, each person is allowed a \$100.00 duty exemption on articles acquired abroad. (Gifts valued under \$10.00 can be sent to the U.S. duty free, provided not more than one parcel a day is addressed to the same person. Gifts may not include liquor or tobacco, and the parcel must be marked as "GIFT". These items need not be declared on return, nor the value deducted from the exemptions.) The liquor laws of the State of California provide that a returning U.S. resident 21 years of age or older arriving in California may include not more than one quart of alcoholic beverages in his customs exemption.
