### Lennart-

Thanks for the helpful information. My grandmother's family was German, but her own father became a naturalized American citizen before joining the rest of his family in China. My grandmother is definitely not buried in the cemetery as she's alive and well and living here in the U.S.! She is following my research with some interest, as you might imagine. Also, she speaks German and Chinese (although she does not read Chinese), so she is helping me with translations.

My grandmother believes all of the Krippendorffs listed in the Tsingtao burial records are her relations. It's a bit hard to know who is who because they all tended to have the same names. For example, my grandmother's father was known as Heinrich, but he had an older brother known as Heinrich, and their father's name was also Heinrich. I think that the August Wilhelm Paul Hugo Krippendorff listed in the cemetery records was actually another older brother of grandmother's father (i.e. another of her uncles). As I mentioned before, her two uncles Heinrich and Hugo owned the Krippendorff Hotel in Tsingtao and her own father later (1920s-1940s) owned the Little Louvre and Savoy Hotels in Tientsin. Apparently, my grandmother also had an aunt named Tekla (or Thekla) but she cannot be the baby listed, because she did not die as a baby. What is interesting to me is that August Wilhelm Paul Hugo is listed on the cemetery records as having died of pneumonia in 1904. My grandmother was told that her uncle Hugo died in the Boxer rebellion (which would have been a couple of years earlier) and she was even shown a picture of his head on a spike that the Chinese had made into a postcard.

Regarding the baby in the cemetery records, Hugo Heinrich who died on August 16, 1900, his parents are listed as Heinrich Krippendorff and Martha (Detleffsen) Krippendorff. My grandmother recalls that her own paternal grandmother's maiden name was Detleffsen (but cannot remember her first name), but it would seem odd for her to have at least four full grown children (the two Heinrichs, Hugo and Thekla) and a baby, although I suppose it's theoretically possible. It would seem more likely to me that this Heinrich and Martha were her aunt and uncle, rather than her grandparents.

Regarding the Frau Krippendorff, the records say she is buried in Tientsin. My grandmother remembers that her own grandmother was buried in Tientsin, as she used to visit the grave, but this woman would not have been old enough to be her grandmother.

Thank you for the information about the German Evangelical Church records. I am going to try to get the Tsingtao cemetery list and also any records they may have about my grandmother's parents and other family members.

Feel free to include my email on your website. As far as a page on your website, I really don't have much documentation yet - much of my information comes from my grandmother. Regarding the hotel in Tsingtao, I do have the attached Taiwanese blog that talks about Tsingtao's history (and google translation). I've also found a couple of Kobe University translations of old Tsingtao news briefs (attached) that mention Hugo's death and his brother's bankruptcy. I will certainly share with you anything else I find.

I am not sure, put the publication you may be asking about is a booklet. The information I have in German is:

'Das Evangel. Zentralarchiv in Berlin hat ein Heft, Signatur A 36, mit der Liste der Gräber von 1898 bis 1932."

The Evangelical Central Archive in Berlin has a booklet, A 36signature, with the list of graves from 1898 to 1932.'

You should email them and ask if you could get a copy of the booklet (perhaps they will photocopy or scan it for you). If you do receive a copy, it would be great if you could forward a copy to me for my

own research. Thanks.

Unfortunately, I do not have any more information on your family. However I did a Google search on 'Krippendorff Hotel Tsingtau', and got a few hits, one mentions the hotel in a record at the Getty archives and one short reference is in a German handbook to the city.

If you get more information or photograph(s) of the hotel or concerning your family's time in Tsingtao and you can email it to me, I could create a webpage on my site if you would like. My online book would then link to it. It would be of interest to readers to get a more complete picture of life in old Tsingtao - a life actually which was quite varied and interesting.

My grandmother, Agnes Charlotte nee Krippendorff was born in Tientsin and lived there until 1938.

She had two uncles, one also known as Heinrich Krippendorff and another,

Hugo Krippendorff whom I suspect to be the August Wilhelm Paul Hugo Krippendorff listed in the cemetery record I found on your website.

Hugo and Uncle Heinrich owned the Krippendorff Hotel and apparently various other restaurants and food supply companies in Tsingtau around 1900.

I am particularly interested in getting access to the German protestant church book that you mention on your site. I know that my grandmother was baptized in the "Deutsche Evangelische Kirchengemeinde" in Tientsin. Do you have any idea how I could access that book? Also, do you have any other information that might be helpful to me.

Thank you very much for compiling that information on your website and thank you in advance for any other information you may have for me.
